Bidwell, Commander A. Trood, USN (USNA, 1908) Served as executive officer on board the armored cruiser Rochester (ACR-2) in the early 1930s, 119-120; while in the Bureau of Navigation in 1940, assigned McCrea to work for Admiral Harold Stark, the CNO, 120-121

Bittern, USS (AM-36)

Minesweeper that McCrea took command of in the Asiatic Fleet in 1924, 64-65; took scientists on an expedition to the Dutch East Indies in the mid-1920s, 65-71; provided assistance for the commercial passenger ship *Irene* near Chefoo, China, in July 1925, 101-105

Blandy, Rear Admiral William H. P., USN (USNA, 1913) Discussions in 1942 with McCrea about the capabilities of radar, 300; reduced in rating as a Naval Academy first-class midshipman in 1913 because he didn't get to formation on time, 300-301

Boston, Massachusetts McCrea's first trip to during midshipman cruise in 1912, 22; tour with his wife, 23-24

Boston Navy Yard

USS Constitution's deteriorated condition in this yard in 1912, 22; manufactured battleship anchor chains in 1912, 22-23; repaired damage to the battleship *Iowa* (BB-61) in 1943, 219, 305

Brooke, Senator Edward

Influence on the Panama Canal Zone decision in 1977, 116

Brown, John Nicholas

Asked McCrea for advice while serving as Assistant Secretary of the Navy for Air shortly after World War II, 332-334

Casablanca Conference

British Prime Minister Winston Churchill's participation in this January 1943 conference, 145-146; rumors circulated in Washington, D.C., in 1942 that President Franklin D. Roosevelt was planning a trip to North Africa, 309-312; Roosevelt traveled to the conference by a series of airplane hops, 312-313

Casey, Commander Thomas J., USN (USNA, 1923) Was executive officer of the battleship Iowa (BB-61) when a torpedo was inadvertently fired at the ship in late 1943, 234; highly recommended for job as XO of the Iowa, 298-299 Cassard, Commander William G., CHC, USN Chaplain who got midshipmen disciplined for misbehavior during choir practice at the Naval Academy in 1911, 201-202 Chatfield, Admiral Alfred E. M., RN (Ret.) Former British First Sea Lord who made speeches against Prime Minister Winston Churchill during World War II, 144 China The minesweeper USS Bittern (AM-36) provided assistance to the commercial passenger ship SS Irene that ran aground near Chefoo in July 1925, 101-105 Churchill, Winston British Prime Minister visited the United States in 1942 to confer with President Franklin D. Eisenhower because he tolerated attacks on General George Marshall in the early 1950s, 354-355

Ghormley, Vice Admiral Robert L., USN (USNA, 1906) Was reassigned from London to duty as Commander South Pacific Area in 1942, 170-171

Glassford, Rear Admiral William A., Jr., USN (USNA, 1906) Navigator when the USS *Idaho* (BB-24) was sold to Greece in the summer of

Surface ships tangled with the battleships *Iowa* (BB-61) and *New Jersey* (BB-62) at Truk Atoll in February 1944, 248-250

Visited by the minesweeper USS Bittern (AM-36) in the mid-1920s, 67

Kennedy, Joseph P., Sr.

As U.S. Ambassador to the United Kingdom in the late 1930s, opinion of the British on the threshold of World War II, 90

Kimmel, Admiral Husband E., USN (USNA, 1904)

Visited the British fleet in World War I to inspect gunnery, 83-84, 90, 96-97; as Asiatic Fleet destroyer division commander in the early 1920s, quite interested in readiness for war, 84-85; became Commander in Chief Pacific Fleet in February 1941, 85-86; McCrea's praise of, 86; worked ships hard near Pearl Harbor in 1941, 9293; visited the new battleship *Iowa* (BB-61) at McCrea's invitation in 1943, 93-96; compared with Admiral William Standley, 197-198

Kimmel, Dorothy

Wife of Commander Husband E. Kimmel, stayed home to take care of family while her husband went to the Far East in the early 1920s, 84-85

MacArthur, General of the Army Douglas, USA (Ret.)

Married Jean Faircloth in New York in 1937, 185; meeting with McCrea in Japan in the late 1940s, 190-194; recalled from the Far East by President Harry Truman in 1951, 193-195; intimidated Admiral Dewitt C. Ramsey, Pacific Fleet Commander in Chief, in the late 1940s, 342

Maine, USS (BB-10) Sent to the Mediterranean to pick up the crew of the Idaho (BB-24) in the summer of 1914, 27, 30-33

Marshall, General of the Army George C., USA Addressed Naval Academy graduates in 1951 as Secretary of Defense, 230; criticized by Senator Joseph McCarthy in the early 1950s, 354-355; delayed bringing home U.S. Army dependents from the Philippine Islands on the eve of World War II, 355-356

Massachusetts, USS (BB-2)

Conditions on board during midshipmen's summer cruise on the East Coast in 1912, 18-22

McAdoo, William G. Former Secretary of the Treasury who discussed his business experiences with McCrea on Guam in the 1930s, 183, 186-88

McCandlish, Captain Benjamin V., USN (USNA, 1909) As Governor of Guam and commandant of U.S. Naval station there, assisted McCrea in 1930s in finding sources of fresh water on Guam, 174-179
