Marine Corps aviator in World War I, pp. 16, 25.

## Darden, Colgate W., Jr.

Enlisted in French Army in 1916 and served in France, where he got bronchial infection, pp. 1-6; sense of idealism about U.S. war effort, pp. 4-6; received naval aviation training in 1917-1918 after return from France, pp. 6-15, 18; transferred to Marine Corps in 1918 and served with aviation contingent in France, pp. 16-30; Darden injured in spectacular aircraft accident in October 1918 and took some months to recover, pp. 30-36; as member of House Naval Affairs Committee in 1930s and early 1940s, pp. 37-79.

Fighter-bomber aircraft flown by Marine Corps in World War I, pp. 22-24, 30-32.

## Dirksen, Everett M.

U.S. Representative who resigned his seat because of eye problems, pp. 65-66.

## Disarmament

Effect on U.S. Navy in 1930s, pp. 39, 43-46, 60, 76-77. See also: Isolationism.

#### Food

Quality of for U.S. naval aviation students in 1918, pp. 10-11.

#### Florida

Naval aviation training at various sites in the state during World War I, pp. 9-15, 18; Marine Corps aviation training during World War I, pp. 16-23, 33-34.

#### France

Darden enlisted in French Army in 1916 and served in France, pp. 1-6; Northern Bombing Group of U.S. fliers operated near Calais in 1918, pp. 24-35.

## Geiger, Roy S., Major, USMC

Commander of a Marine Corps squadron in the Northern Bombing Group in France during World War I, pp. 25-26.

#### Germany

German Air Force operations over France in 1918, pp. 28-29; U.S. intelligence estimates of German military and naval strength prior to U.S. entry into World War II, pp. 47-49, 72.

#### Great Britain

Darden recuperated in London after aircraft accident in 1918, pp. 35-36; President Franklin D. Roosevelt traded old U.S. destroyers to British in 1940, pp. 70-71, 74-75.

#### Guam

U.S. attempts to fortify in 1930s, pp. 43-45.

## Gunnery

Aerial gunnery training in Florida during World War I, pp. 20-23.

#### H-16

Large Navy flying boat considered hazardous to fly in World War I, pp. 17-18.

#### Isolationism

Attempts to keep the United States from getting involved in the international scene in the 1930s, pp. 63-65, 69-70, 73, 76-77.

## Japan

U.S. attempts to avoid provoking Japan before World War II, even though it was likely enemy, pp. 43-46, 66-67.

#### JN-4

Land biplane flown by the Marine Corps in World War I, p. 19.

## Lighter-than-air Craft

#### Maas, Melvin J.

U.S. Representative who strongly supported Navy in the years leading up to World War II, p. 52.

### Marine Corps Aviation

Darden transferred to Marine Corps in 1918 for training and then served with Northern Bombing Group in France, pp. 16-35.

## Massachusetts Institute of Technology

Site of naval aviation ground school training during World War I, pp. 7-9.

## N-9

U.S. naval aircraft used for training in 1918, pp. 12-13.

## Naval Academy, U.S.

Some midshipmen graduated but not commissioned because of Depression in 1930s, later recalled, pp. 41-42, 59; Darden as member of board of visitors examining curriculum in 1930s, pp. 67-68.

Naval Affairs Committee, House of Representatives Activities of in 1930s and early 1940s, pp. 37-79.

### Naval Aviation

Darden received training at MIT ground school in 1917, PP. 7-9; training at various sites in Florida in 1918, pp. 9-15; supported by Congress in 1930s, p. 61.

Nimitz, Chester W., Rear Admiral, USN (USNA, 1905)
Impressive witness when testifying before Congress as Chief of the Bureau of Navigation just prior to World War II, pp. 77-79.

## Northern Bombing Group

U.S. Navy-Marine Corps flying contingent in France during World War I, pp. 24-35.

### Rankin, Jeannette

U.S. Representative with deep isolationist sentiments in both World Wars, pp. 64-65.

## Roosevelt, Franklin D.

President in 1930s and 1940s, pp. 37-41, 50, 58-59; 70-72, 74.

## Roosevelt, Henry L.

Assessment of as Assistant Secretary of the Navy in the 1930s, p. 57.

## Seaplanes

Used for U.S. naval aviation training in 1918, pp. 12-14, 17-18.

## Shipbuilding Program--U.S. Navy

Size of in 1930s dictated by various considerations, pp. 39, 56-60, 73.

## Shore Stations--Naval

U.S. facilities needed improvements in the 1930s, p. 62.

## Stark, Harold R., Admiral, USN (USNA, 1903)

U.S. Chief of Naval Operations whom Darden feels was done an injustice after the attack on Pearl Harbor, p. 50.

### Submarines

U.S. intelligence overestimated capability of German U-boat force prior to World War II, pp. 47-48.

## Talbot, Ralph, Second Lieutenant, USMCR

Medal of Honor winner killed in spectacular aircraft accident in France in October 1918, pp. 30-33.

## Thomas Scout

U.S. aircraft used in World War I training, p. 19

## Training

Naval aviation instruction in Massachusetts and Florida in 1917-1918 pp. 7-15, 18, 33-34; Marine Corps aviation training in Florida in 1918, pp. 16-23.

## Vinson, Carl

U.S. Representative who headed House Naval Affairs Committee in 1930s and 1940s, pp. 46, 51-52, 60-61, 73-74.

## World War I

Darden enlisted in French Army in 1916 and served in France, pp. 1-6, naval aviation training in United States during war, pp. 7-15; Marine Corps aviation during the war, pp. 16-36.
