Bass, USS (SS-164)

Crewmen killed by battery fire while submarine was operating off Panama, 17 August 1942, p. 66.

Batfish, USS (SS-310)

Sinks Japanese submarines in vicinity of the Philippines in February 1945, p. 109.

Bathythermograph

Use of to find temperature gradient so submarines can stay on station without use of power, p. 158-159.

Beakley, Rear Admiral Wallace

Impressions of while serving as Admiral Dennison's chief of staff in 1960, p. 268-269.

Bennett, Lieutenant John E.

On board cruiser *San Francisco* when damaged at Guadalcanal in November 1942, p. 86; attended submarine school, then reported to USS *Queenfish*, p. 86; rescues POWs from sea and reads burial service for those who died, p. 101; officer of the deck of USS *Queenfish* after sinking of *Akitsu Maru* in November 1944, p. 107; notifies Loughlin of sinking of *Awa Maru*, p. 125.

Beshany, Vice Admiral Philip A.

Former *S-14* shipmate of Elliott Loughlin; eager to get submarine command right after World War II, p. 140.

Boone, Rear Admiral Walter F. ("Freddie")

Superintendent of Naval Academy in mid-1950s with whom Loughlin had difficult working relationship, p. 192-194, 197-199; invites Hr. Norman Vincent Peale to preach at Naval Academy, p. 227-228.

Brockett, Rear Admiral William A.

One of several USS *New Mexico* division officers in 1930s who later made flag rank, p. 25; best man at Elliott Loughlin's wedding, p. 27.

Bruton, Captain Henry Chester

As Loughlin's defense counsel at *Awa Maru* court-martial in 1945, p. 128, 130, 133.

Buchanan, Captain Charles A.

Served with Loughlin in USS *New Mexico* in 1930s; as Naval Academy commandant, had a hand in selecting Loughlin as athletic director in 1954, p. 182-133; difficulties with football coach Eddie Erdelatz, p. 185-186.

Burke, Admiral Arleigh A.

Dissatisfied with U.S. Navy antisubmarine warfare while CNO in 1950s, p. 256; description of personality, p. 256-257.

Burlingame, Captain Creed

Submarine squadron commander in Panama after World War II, forced to revert from captain to commander along with rest

of his Naval Academy class, p. 152-154.

Church, Captain Albert T., Jr.

Skipper of cruiser *St. Paul*, p. 275; career hurt when his ship collides with carrier *Coral Sea* in early 1960s, p. 278-279.

Trial of CDR Elliott Loughlin, skipper of USS *Queenfish* in 1945 for sinking of Japanese *Awa Maru*, p. 127-134.

Crawford, Captain George C. ("Turkey Neck")

As COMSUBLANT chief of staff in June 1944, helped conduct short-notice inspection of USS *Queenfish*, p. 148-149.

Cruiser-Destroyer Flotilla 9

Commanded by Rear Admiral Loughlin in early 1960s, p. 272-279; in USS *Oklahoma City* on West Coast, p. 272-274; in USS *St. Paul* in Far East, 275-279.

Daubin, Rear Admiral Freeland

As COMSUBLANT in spring of 1944, conducts short-notice inspection of USS *Queenfish*, p. 148-149.

Dawson, Lieutenant (junior grade) William L.

At Loughlin's wedding, p. 27.

Daughters

Birth of first daughter on Memorial Day, 1936, p. 37; birth of second daughter, July 1937, p. 39.

DeGaulle, General Charles

Pulls France out of military participation in NATO

alliance in early 1960s, p. 284-285.

Dempsey, Rear Admiral Tames C.

While serving as OP-09B in mid-1960s, was immediate boss of Loughlin and other naval district commandants, p. 321, 323.

Dennison, Admiral Robert L.

As Supreme Allied Commander Atlantic (NATO command), 1960, p. 263-264, 268-271; during 1962 crisis, p. 281.

Diem, Ngo Dinh

As president of South Vietnam in early 1960s, description of personal characteristics, p. 247.

Dornin, Ensign Robert E. ("Dusty")

As junior officer in USS *New Mexico* in 1935, p. 28; member of outstanding group of students at submarine school in late 1930s, p. 45.

Doyle, Admiral Austin K. ("Artie")

Flew flying boats at Naval Academy in early 1930s as means of recruiting prospective aviators, p. 15-16.

Dutton, Captain Benjamin, Jr.

Commanding officer of USS *Wyoming* when she encountered hurricane during midshipman training cruise of 1931, p. 9.

Dykers, Captain Thomas M.

As commanding officer of USS *S-35* in late 1930s, p. 49-53, 56; as originator of "Silent Service" TV program after World War II, p. 50-53; successful CO of submarine USS *Jack* in World War II, p. 53; as COMSUBLANT planning officer in late 1940s, p. 150-151.

Eddy, Captain Ian

Loughlin's predecessor as Naval Academy director of athletics, p. 182.

Enright, Lieutenant (junior grade) Joseph F.

Served in S-boat submarines, p. 50.

Erdelatz, Eddie

As Naval Academy head football coach in 1950s, p. 185-191, 197, 204-205.

Escolar, USS (SS-294)

Submarine lost in Japanese minefield in autumn of 1944, p. 116.

Evans, Vice Admiral Charles

Royal Navy officer serving as Deputy SACLANT in 1960, philosophy on offering drinks, p. 262-263.

Ewen, Lieutenant Edward C.

Naval aviator on board the USS *New Mexico* in the 1930s, p. 43.

Fife, Admiral James, Jr.

As believer in blimps for ASW, p. 92; allowed to go on submarine war patrols and got fourth star as result, p. 113-114; description of personality and working habits, p. 149-151; advises Loughlin about Naval Academy billet during inspection tour to Panama, p. 161-162.

Flaherty, Captain Michael F.

Billet changed after being ordered to command naval station at Annapolis, p. 162-163.

Fleet, U.S.

Impressions of fleet review at New York City in June 1934, p. 34-35; Hawaiian Detachment in high state of readiness under Admiral J. O. Richardson in October 1940, p. 55.

Fletcher, Captain Frank Jack

Impressions of him during period as commanding officer of USS *New Mexico* during the late 1930s, p. 34, 36-37.

Fluckey, Rear Admiral Eugene R.

As commanding officer of USS *Barb* during wolf pack operations in late 1944, p. 93-97, 116-117, 119; qualities as superb naval officer, p. 105, 217; Medal of Honor winner, p. 109; sends landing party ashore to blow up railroad tracks in Japan, p. 145; heads fund-raising drive for Naval Academy stadium in 1950s, p. 216-217; serves tour as COMIBERLANT in Portugal, p. 284.

Foley, Commander Robert J.

Discovers unexploded depth charge on deck of USS *Gato*

while serving as CO in December 1944, p. 102-103.

Site of U.S. submarine wolfpack operations in late 1944 by *Barr*, *Picuda*, and *Queenfish*, p. 115-120.

France

Pulls out of military participation at DeGaulle's direction in early 1960s, p. 284-286.

Freeman, Captain Charles L. ("Larry")

Various billets held by: *S-34*, *USS Williamsburg*, CO of Annapolis Naval Station, duty on Eisenhower's staff, p. 161-162; requests permission to serve liquor on board *Reina Mercedes* at Naval Academy, turned down, p. 166-167.

French Frigate Shoals

Used as site of U.S. submarine training operations in late 1930s, p. 54-55.

French Navy

Ships of free French fleet at Guadeloupe in World War II, p. 65.

Fyfe, Lieutenant Commander John K.

Sinks Japanese submarines in the vicinity of Philippines while commanding *USS Batfish* in February 1945, p. 109.

Gato, USS (SS-212)

Unexploded depth charge found on deck during war patrol in December 1944, p. 102-103.

Gatch, Rear Admiral Thomas L.

As Navy Judge Advocate General in 1945, writes endorsement on Loughlin's *Awa Maru* court-martial, p. 137.

Gilmore, Morris

Responsible for Naval Academy Athletic Association owning land in Admiral Heights section of Annapolis, p. 215.

Greig, Commander Stuart O.

Does fine job rotating junior officers while serving as executive officer of the *USS New Mexico* in the mid-1930s,

p. 32.

Grenfell, Vice Admiral Elton W. ("Joe")
Impressions of while serving as Commander Submarine
Flotilla 1 in early 1950s, p. 175-176; on selection board
when Loughlin made flag rank, p. 271-272; asks Loughlin to
take over ComSubFlot 6 in 1964, p. 295.

Halsey, Fleet Admiral William F.
Served as commanding officer of OSS *Reina Mercedes*, p.
163.

Harral, Lieutenant Commander Brooks
flakes patrol to Galapagos Islands early in World War II
while commanding HSS S-17, p. 67.

Hart, Rear Admiral Thomas C.
Impression of personality while serving as Naval Academy
Superintendent around 1930, p. 16.

Hawk, Lieutenant Earle C.
One of only three survivors when USS S-26 was sunk in Gulf
of Panama in January 1942, p. 33; acquitted at subsequent
court-martial, p. 136.

Hensel, Commander Karl G.
As instructor at submarine PCO school in 1943, p. 76.

Hebert, F. Edward
Louisiana congressman seeks tickets for 1955 Sugar Bowl
game, p. 193-195.

Higgs, Lieutenant Commander Aired Henry ("Harry")
Exec of *Queenfish* under Loughlin, claimed damage to large
ship, p. 146.

Hill, Rear Admiral Harry W.
As superintendent of Naval Academy in early 1950s was
enthusiastic sports booster, p. 169, 173; critical of
incomplete gun salute to French president, p. 171-172.

Hoffheins, Lieutenant Commander William L. ("Willy")
Operations officer of Coco Solo submarine base early in
World War II, p. 61.

Holloway, Admiral James L., Jr.

As superintendent of Naval Academy in late 1940s, turns down request to serve liquor on board the *Reina Mercedes*, p. 166-167; as CIMCNELM, commands Lebanon landing in 1958, p. 236.

Hoover, Vice Admiral John H. ("Genial John")

As Commandant 10th Naval District at San Juan at beginning of world War II, p. 60, 62; as president of *Awa Maru* court-martial in 1945, p. 129-130.

Hopkins, Midshipman Thomas W. ("Tommy")

Graduated from Naval Academy in 1932; he and sister Kitty were members of Annapolis family, p. 20.

Houston, USS (CA-30)

U.S. cruiser sunk in early 1942; when Japanese ship was sunk in September 1944 and POWs rescued, it was first U.S. knowledge of any *Houston* survivors, p. 99.

Iberian Atlantic Command (COMIBERLANT)

Infrastructure in place before command activated under Rear Admiral Fluckey, p. 284.

ICRM

See Missile Testing.

Ingram, Admiral Jonas

As CINCLANTFLT in 1945, counsels Loughlin on effect on career of *Awa Maru* incident, p. 135.

Irvin, Captain William D.

As communication officer on COMSUBPAC staff in 1944-45, p. 92, 127.

Jacobs, Captain Randall

Became commanding officer of USS *New Mexico* as Loughlin was leaving, p. 32.

Jahncke, Midshipman Ernest Lee, Jr. ("Ernie Lee")

Son of former Assistant Secretary of Navy, served as compartment cleaner on midshipman cruise, p. 9.

Japan

Impression of by Loughlin while serving there, p. 178-180, 275-277.

Jean Bart

French battleship at Guadeloupe early in World War II, p. 65.

Kane, Midshipman William R.

Member of class of 1933 who lettered in three sports while at Naval Academy, p. 13.

Kauffman, Midshipman Draper L.

Member of class of 1933 who served as compartment cleaner during Naval Academy midshipman cruise, p. 9.

Kelly, Colonel Sid

Commanded Marine detachment at Annapolis in early 1950s, p. 164.

King, Fleet Admiral Ernest J.

As Commander in Chief, U.S. Fleet, reaction to *Awa Maru* court-martial in 1945, p. 126-129.

King, Commander Thomas S., II

Assistant to executive officer of Naval Academy in 1933, arranges for Loughlin's orders to be changed to USS *New Mexico*, p. 24.

Kivette, Vice Admiral Frederick N.

Commander Seventh Fleet in 1959, p. 243.

Klinker, Lieutenant Commander Roy C.

Fails to send contact report while commanding USS *Sea Fox* during submarine wolf pack operations in March 1945, p. 122-123.

Kridel, Frank

Friend of Loughlin's who was instrumental in getting Norman Vincent Peale to visit Naval Academy in mid-1950s, p. 227-228.

Laing, Captain Frederick W.

As commanding officer of submarine tender *Orion* in 1947, p. 152-155.

Lake, Lieutenant Richard C.

As commanding officer of submarine USS *S-14* in early 1942, undergoes diving emergency, then detached, p. 63-65.

Leahy, Frank

Notre Dame coach briefs crew of USS *Queenfish* on football as part of USO work in World War II, p. 112.

Lebanon

U.S. landing at Beirut in 1958, p. 232, 236.

Lee, Commander John F.

Submarine squadron commander at San Diego in early 1950s, p. 176.

Leeds, Midshipman John R. ("Bud")

Company commander at Naval Academy in the early 1930s, p. 18.

Liberty, USS (AGTR-5)

Intelligence ship attacked by Israelis in 1967; Loughlin conducted ceremony when skipper awarded Medal of Honor, p. 324.

Lockwood, Vice Admiral Charles A.

Commander Submarine Force Pacific Fleet during World War II, at Pearl Harbor, p. 92; at Guam, 111-113; retired as vice admiral because not permitted to make war patrols, p. 114; reaction to sinking of Japanese *Awa Maru* in 1945, p. 126-128, 133-134.

Long Beach, USS (CGN-9)

First skipper, Eugene Wilkinson had great technical proficiency, p. 315.

Luzon Strait

U.S. wolf pack operations there in late 1944 by submarines *Barr*, *Picuda*, and *Queenfish*, p. 93-99.

Mackerel, USS, (SS-204)

Small submarine used for tactical, training of prospective CDs at new London during World War II, p. 75.

Magic Carpet

Operation after World War II to return ships and men to the United States, p. 140-142.

MARLIN, USS (SR-205)

Small submarine used for tactical training of prospective COs at New London during World War II, p. 75.

Martin, Benjamin S.

Topflight football coach who left Naval Academy because he couldn't work with Eddie Erdelatz, p. 204-205.

McCandless, Lieutenant Commander Bruce

Received Medal of Honor for bringing back cruiser *San Francisco* when damaged at Guadalcanal in 1942, p. 84.

McKee, Captain Andrew I.

Recognized as best submarine designer in world; got results for submarine skippers while at Portsmouth Navy Yard in World War II, p. 80-81.

Messina, Straits of

Passage between Italy and Sicily has treacherous currents which make shiphandling difficult, p. 234.

Metcalf, Lieutenant Ralph M.

Becomes skipper of USS *Pogy* during World War II when predecessor has to be relieved, p. 71.

Miller, Commander Rollo

Commanding officer of submarine in which Loughlin rides as division commander in late 1940s, p. 157.

Millican, Commander William John

Skipper of submarine USS *Escobar* when she was lost in Japanese minefield in October 1944, p. 116.

Missile Testing

Firing of Polaris A-3 in 1960s, p. 307-308; Air Force unable to fire ICBM for observation by space ship, p. 307.

Mississinewa, USS (AO-144)

Fleet oiler commanded by Captain Loughlin in 1957-1958, p. 228-239; converted to flagship for Commander Service Force Sixth Fleet, p. 229-230; shiphandling and refueling, p. 230-231; Sixth Fleet ops, including 1958 Lebanon crisis, p. 232-239; quality of officers, p. 237.

Morale

Given boost for submariners during World War II by publication of submarine exploits, p. 109.

Mountbatten, Lord Louis

Stature as a NATO commander in 1950s, highly respected, p. 264.

Mustin, Rear Admiral Lloyd M.

Impressions of while serving in the ASW readiness section of OpNav in 1960, p. 253.

NATO

Loughlin serves as Director of Plans for SACLANT in 1960-1961, p. 258-271; SACLANT must be U.S. admiral, p. 259; nature of planning job, p. 261-262, 265; views of top commanders: Mountbatten, Norstad, Dennison, p. 264-268; difference between national and NATO forces, p. 291-295. Loughlin serves as deputy chief of staff, SACLANT, 1962-1964, p. 288-295.

Nauman, Lieutenant Commander Harley K.
